



Friday Private Practice for Round 5 **2022 Motorsport Australia Victorian State Circuit Racing Championships 2022** **FRIDAY 23rd September 2022**

To be read in conjunction with the 2022 Motorsport Australia Victorian State Circuit Racing Championships Series Regulations, available from the Organisers.

1. EVENT DESCRIPTION AND AUTHORITY

The Event will be a **Friday Private Practice for Victorian State Championships Circuit Race Event**, conducted at the Phillip Island Grand Prix Circuit over a lap distance of 4.45km in an anti-clockwise direction on 23rd September 2022, held under the FIA International Sporting Code including Appendices, National Competition Rules of Motorsport Australia, the Circuit Race Standing Regulations, the 2022 Motorsport Australia Victorian State Circuit Racing Championship Series Regulations, the Phillip Island Grand Prix Circuit Standing **Motor Car** Race Regulations (Issue 05-2018), these Supplementary Regulations and any Further Regulations or instructions issued for the Event.

This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1st and Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au

Entries will be accepted in order of receipt, until the track density for each category has been reached

The preferred method of Entry for this Event will be via the Motorsport Australia Event Entry online system www.evententry2.motorsport.org.au. The Entry Fee is \$250.00 (GST inclusive) for all entries. The full Entry fee must be received before your entry can be considered as accepted.

Garage hire for the day will be allocated to those competitors hiring the garage for the weekend. Hire fee are Garage 1 -40 \$185, 41 to 59 \$280, Carports (Green Paddock Sheds) \$165 for Friday.

The Organiser reserves the right to accept or reject any Entry as per the NCR.

Entries open on publication of these Regulations and close on 23rd September 2022

Each Competitor must hold the minimum of a Motorsport Australia ~~Competition Circuit~~ Licence with a provisional endorsement, unless they comply with (a) or (b) below. Each Driver must hold a minimum of a Motorsport Australia Circuit Race Licence with Provisional endorsement or;

(a) hold a Motorsport New Zealand competition Licence and Tasman Visa valid for the Event; or

(b) hold a minimum of the highest grade National Licence issued by a foreign ASN s together with an authorisation issued by that ASN for the Event; each such Driver and Competitor:

(i) shall be ineligible to score points in any Championship/Cup/Series/Trophy/etc connected with the Event; and

(ii) must receive an authorisation to compete from Motorsport Australia prior to the Event;

INVITED CATEGORIES

Formula Ford 1600 & Formula Ford, Formula Vee, Improved Production Cars, Sports Cars– as listed in Appendix A of the 2022 VSCRC Regulations, Porsche 944 Challenge, Saloon Cars, Circuit Excels, Sports Sedans, HQ Holdens, BMW E30, Historic Touring Cars. Other compatible vehicles may be accepted.

SCRUTINY

Targeted Scrutiny procedures will be applied at this Event using Motorsport Australia Return to Race Self-Scrutiny. Automobile and Apparel Compliance Document shall be used and likewise Self Scrutiny Checklist.

GENERAL

Each Competitor must present their appropriate Motorsport Australia Licence Card, Motorsport Australia Licence Passbook, and Automobile logbook at Check In as well as the Return to Race Self Scrutiny Compliance document and Check list.

All Driver apparel shall be in accordance with Schedule D of the Motorsport Australia Manual.

Protests, if any, must be lodged in accordance with the NCR.

The Promoter reserves the right to cancel, abandon or postpone the Event in accordance with the NCR.

Fuel shall be in accordance with Schedule G of the Motorsport Australia Manual.

No timing will be provided for the practice day.

No races will be conducted during this practice day.

ALCOHOL, DRUGS AND OTHER SUBSTANCES

The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of any drug or other banned substance and subject to a penalty for a breach of the Australian National Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy at www.motorsport.org.au.

Consumption of alcohol in the paddock, pits or any other Reserved Area is prohibited until all Competition is concluded each day. The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Alcohol Policy at www.motorsport.org.au.

INSURANCE

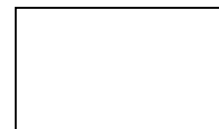
