The Event will be a Victorian State Championship Race Event, conducted at the Phillip Island Grand Prix Circuit in an anticlockwise direction from the 24th – 25th September 2022, held under the FIA International Sporting Code including Appendices, National Competition Rules of Motorsport Australia, The Circuit Race Standing Regulations, the 2022 Motorsport Australia Victorian State Circuit Racing Championship Series Regulations, the Phillip Island Grand Prix Circuit Standing Motor Car Racing Regulations, these Supplementary Regulations and any Further Regulations or instructions issued.

This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1st and Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au.

EVENT DESCRIPTION

The Event will be a **State Championship Race Event** held over two days. The activities will be conducted at the Phillip Island Grand Prix Circuit and cars will circulate in a anticlockwise direction.

ENTRIES

The preferred method of entry is via Motorsport Australia Event Entry – Go to www.motorsport.org.au , sign in then follow the link to Motorsport Australia Event Entry.

Entries will open on publication of these Regulations and close on 17th September 2022.

Entries may be refused in accordance with the NCR of the Motorsport Australia Manual.

The Entry Fee will be **\$495.00** (GST Inc)

A surcharge of \$110 including GST applies to any entry which nominates for more than one category with the same Driver. In these cases the Driver must indicate on the Entry Form their first and second choice of which category they would like to run. A separate full Entry Fee is payable if the cross entry is for the same vehicle but with a different Driver. A separate full Entry Fee is also payable if a Driver enters more than one category with a different vehicle. Individual entries must be completed by for each car and Driver.

All Drivers must be current financial member of a Motorsport Australia affiliated club and hold a minimum of a Motorsport Australia Circuit Licence with provisional endorsement.

Competition Numbers will be allocated at the Promoters discretion, where possible according to the categories' allocated numbers which have been supplied to the series by the Category Representatives. Numbers will otherwise be allocated to best fit with category allocations and Competitors wishes as much as is possible. Only two figure numbers will be permitted.

GARAGE HIRE

Garages may be hired via Motorsport Event Entry.

GENERAL INFORMATION

Certain public, property, professional indemnity, and personal accident insurance is provided by Motorsport Australia in relation to the Event. Further details can be found in the Motorsport Australia Insurance Handbook, available at www.motorsport.org.au

Protests must be lodged in accordance with the NCR of the Motorsport Australia Manual.

The Promoter reserves the right to cancel, postpone or abandon the Event in accordance with the NCR.

Timing will be electronic, and each Competitor will require a Dorian Transmitter, fitted in accordance with the 2022 MOTORSPORT AUSTRALIA VICTORIAN STATE CIRCUIT RACING CHAMPIONSHIPS SERIES REGULATIONS 9 (c)

ALCOHOL, DRUGS AND OTHER SUBSTANCES

The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of any drug or other banned substance and subject to a penalty for a breach of the Australian National Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy at www.motorsport.org.au.

Consumption of alcohol in the paddock, pits or any other Reserved Area is prohibited until all Competition is concluded each day. The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Alcohol Policy at www.motorsport.org.au.

INVITED CATEGORIES

Formula Ford 1600 & Formula Ford, Formula Vee, Improved Production Cars, Sports Cars– as listed in Appendix A of the 2022 VSCRC Regulations, Porsche 944 Challenge, Saloon Cars, Circuit Excels, Sports Sedans, HQ Holdens, BMW E30, Historic Touring Cars.

FUEL REQUIREMENTS

Fuel must comply with Schedule G of the Motorsport Australia Manual.

NOISE

Vehicles must be adequately muffled to comply with the 95 dB noise limit.

SELF SCRUTINY and TARGETED SCRUTINY

Self Scrutiny will apply at this event. The Self Scrutiny check list and Statement of Compliance are attached and must be presented along with the vehicle log book at Check-In. Targeted Scrutiny procedures will apply. **PLEASE NOTE. A photocopy or scan of the vehicle log book showing the last audit and the Events since is required to be submitted via Email to vscrcfive@gmail.com**

Vehicle Logbooks will be checked by Scrutineers to confirm which vehicles are due for audit;

All Driver apparel and helmet shall comply with Schedule D of the 2022 Motorsport Australia Manual and is also subject to Targeted Scrutiny.
